4 FIRST-AID MEASURES

GENERAL INFORMATION

General first aid, rest, warmth and fresh air. Do not give victim anything to drink if they are unconscious. Get medical attention if any discomfort continues.

EXTINGUISHING MEDIA

PROCESS CONDITIONS
